1. Abstracts should be written in English in this document and sent as a Word file.
2. Article submission is only possible from the website and the results would be announced through the website.
3. The deadline for the submission is 1st December 2023.
4. Abstracts should contain a maximum of 500 words.
5. The presenter of the article in the symposium should be identified by placing a mark (underline) in the authors section of the article.
6. The author of the article in the symposium should be marked with an asterisk (*) in the authors section of the article and his/her email should be written below the authors section.
7. It is possible to use standard and well-known abbreviations in the abstract of the article. (In other cases, for the first time, you can put the abbreviation of specific words in parentheses and then you can use that abbreviation in the rest of the text).
8. The authors are responsible for the scientific accuracy, reliability and ethical aspects of the presented findings in the article.
9. Write at least 3 and at most 5 keywords at the end.
10. The Scientific Committee of the Symposium will review all of the abstracts and the selected abstracts would be announced to be presented as an oral presentation.
11. The abstract structure of the article should be in accordance with the next page.

Complete title

(Title should be centered, in bold and font size 14. Only first letter of title should be in uppercase)

Authors

(Only Presenter underlined, authors should be centered, superscript numbers indicating affiliation should appear after author name, font size 11)

Author affiliations / organizations

(Superscript numbers before organizations, centered, font size 11)

(*Corresponding Author Email)

Background - (Font Times New Roman, size 11, Bold and uppercase)

Paragraph Times New Roman, size 11: Establish the context, background and/or importance of the topic; indicate a problem, controversy or a gap in the field of research.

Objective - (Font Times New Roman, size 11, Bold, and uppercase)

Paragraph Times New Roman, size 11: Indicate the primary purpose of the research.

Methods - (Font Times New Roman, size 11, Bold, and uppercase)

Paragraph Times New Roman, size 11: Provide a description of the research design, data collection and analysis.

Results - (Font Times New Roman, size 11, Bold, and uppercase)

Paragraph Times New Roman, size 11: Provide a summary and discussion of the results. If you are on early stages of your thesis, you can write about the results you are expecting to achieve.

Conclusion- (Font Times New Roman, size 11, Bold, and uppercase)

Paragraph Times New Roman, size 11: A statement of the study's conclusions and/or implication of the results.

Keywords - (Font Times New Roman, size 11, Bold)
