

Memorandum of Understanding for Cooperation

between

Tehran University of Medical Sciences (TUMS)

and

Mad Technical Institute, Kurdistan Region of Iraq

This Memorandum of Understanding is prepared and signed with the aim of enhancing the academic level and developing the capabilities of applicants from the Kurdistan Region of Iraq for studying at Tehran University of Medical Sciences. For this purpose, a Memorandum of Understanding for cooperation is concluded between Tehran University of Medical Sciences, hereinafter referred to as "First party," and Mad Technical Institute, hereinafter referred to as "Second party."

Article 1) Subject of the Memorandum

- Admission of students from the Kurdistan Region of Iraq, introduced by Mad Technical Institute and approved by Tehran University of Medical Sciences.
- Organizing academic courses and scientific workshops in the Kurdistan Region of Iraq in coordination with the First Party.

Article 2) Obligations of Second Party

- Receiving and reviewing initial documents of students.
- Introducing eligible students to First party at various academic levels.
- Handling student-related affairs in the Kurdistan Region.
- Providing necessary consultations to students regarding educational regulations in the Islamic Republic of Iran.
- Planning and organizing joint scientific events, including conferences, training courses, workshops, etc., in the Kurdistan Region, for the purpose of knowledge and technology transfer, in coordination with First party.

Article 3) Obligations of First Party

- Reviewing the documents submitted by applicant students from Second party at the university's admissions office.
- Selecting eligible students based on the university's educational protocols.
- Supporting students in the stages of obtaining visas, providing accommodation, and other student services.



Article 4) Duration of the Memorandum

- The duration of this Memorandum of Understanding is one solar year from the date of signing.

Note 1: It is renewable upon written consent of both parties, three months prior to the expiration date.

Article 5) Other Provisions

- This Memorandum of Understanding for cooperation does not create any legal or financial obligations for either party and is solely a document for establishing and implementing bilateral cooperation.
- Any financial cooperation between the parties shall be subject to the drafting and signing of a separate and independent contract, the terms of which shall be determined by agreement.
- Any intellectual property created as a result of joint cooperation and based on the provisions of this Memorandum of Understanding shall belong to both parties. Neither party is permitted to assign or transfer their rights and obligations to third parties without the prior written consent of the other party.
- Neither Party may use the other Party's name, logo, or any identifying marks in any publication, advertisement, brochure, website, social network, or other media without prior written consent.
- Any disagreement between the parties regarding the interpretation or implementation of any provision of this Memorandum of Understanding shall be resolved amicably through mutual consultation and negotiations between the parties.

This Memorandum of Understanding has been prepared in 5 articles and 2 notes in two copies and signed by both parties on Aug. 25, 2025. Each copy shall have the same force.
