Memorandum of Understanding and Mutual Assistance

This Memorandum of Cooperation and Mutual Assistance (hereinafter referred to as the "Memorandum") is made between Razi Skin Hospital, hereinafter referred to as the "Foundation," represented by the Head of Razi Skin Hospital Seyed Naser Emadi, acting on the basis of the charter, on the one hand, and the "Association of Dermatovenereologists and Cosmetologists of the Republic of Tajikistan," hereinafter referred to as the "Association," represented by the Chairman of the Association, Muzaffar Fayzalizovich Homidov, acting on the basis of the charter approved by the Ministry of Justice of the Republic of Tajikistan, registration IC 531 "B" dated July 27, 2025, on the other hand, hereinafter collectively referred to as the "Parties," have reached mutual understanding on the following:

1. Purpose of Cooperation

- 1.1. The Parties confirm their interest in information cooperation and interaction to assist children suffering from genodermatoses (epidermolysis bullosa and ichthyosis) and other severe dermatoses.
- 1.2. Cooperation and interaction between the Parties will involve the exchange of information, including scientific literature and materials, in areas related to the statutory activities of the Parties.

2. Interaction Between the Parties

- 2.1. The Parties shall hold bilateral meetings as necessary to discuss issues and develop proposals for interaction within the framework of this Memorandum.
- 2.2. The Parties may agree on other formats of cooperation, including the organization of educational seminars, online seminars, master classes, telemedicine sessions, training of doctors in Iran, the involvement of leading specialists for negotiations, decision-making on projects, as well as other directions.
- 2.3. The Parties express their willingness to combine efforts for the maximum realization of the provisions of this Memorandum.
- 2.4. The Parties agree to assist each other in implementing the main directions of interaction within their competencies.
- 2.5. The relationship between the Parties under this Memorandum shall be based on the principles of equality, mutual respect, and the avoidance of business cooperation between the Parties.
- 2.6. This Memorandum does not provide for any financial obligations between the Parties.

3. Duration of the Memorandum

3.1. This Memorandum comes into effect upon signing by both Parties and is valid for one year. If neither Party notifies the other of any changes or termination 30 (thirty) days prior to the expiration of this Memorandum, it shall be automatically extended under the same terms for the same period.

4. Final Provisions

4.1. This Memorandum is governed and interpreted in accordance with the legislation of the Republic of Tajikistan.

4.2. All changes and additions to this Memorandum are valid if they are made in writing and signed by the authorized representatives of the Parties.

4.3. In the event of a change in the name, location, or other details, each Party is obligated to notify the other Party in writing within 30 (thirty) calendar days of the changes.

4.4. This Memorandum is drawn up and signed in two copies, both having equal legal force, with one copy retained by each Party.
