



**ADDENDUM TO THE COOPERATION AGREEMENT BETWEEN THE
UNIVERSITY OF COIMBRA (PORTUGAL)
AND TEHRAN UNIVERSITY OF MEDICAL SCIENCES (I.R. Iran)**

Maintaining the same objectives that led to the signing of the Cooperation Agreement between the **University of Coimbra (UC)** and the **Tehran University of Medical Sciences (TUMS)**, and based on the willingness to continue such Agreement, both institutions agree on signing this Addendum in the following terms:

1. The University of Coimbra, legal number 501 617 582, represented by its Vice-Rector, Prof. Dr. João Nuno Calvão da Silva, under delegated authority given by the order nr. 8819/2020 of September 14, and Tehran university of medical sciences, represented by it's Dean of School of Dentistry, Prof. Dr. Amirreza Rokn, agree to promote academic cooperation between institutions, specifically in the areas of **Dentistry**;
2. The exchange referred to in this Addendum is destined for teachers and researchers of the Department of Dentistry of the Faculty of Medicine of the UC and the School of Dentistry of TUMS for the joint development and organization of research projects, scientific events, courses and programmes, virtual joint short courses as well as the exchange of didactic/academic materials, information and publications;
3. Specific joint activities shall be performed by mutual agreement, through written form, detailing administrative and financial aspects. An action plan will be developed jointly by the Department of Dentistry of the Faculty of Medicine of the UC and the School of Dentistry of TUMS for the agreed activities to expedite the implementation of activities and within a three-month time period after signing this Addendum.
4. Both institutions are committed to the endeavour of obtaining financial resources required for the development of the different cooperation activities;
5. The selection procedure for beneficiaries of the exchange shall be made in accordance to the criteria defined by the parties;

6. Teachers and researchers participating in the cooperation programmes herein envisaged shall follow the immigration policies of the host institution's country and arrange for international coverage insurance during their stay abroad;
7. The UC and TUMS will receive teachers and researchers, in equivalent number, up to a maximum of 2 staff members per semester;
8. Costs with accommodation, transport, as well as personal expenses, will be responsibility of the beneficiaries of exchange;
10. The coordination of the activities envisaged by this Addendum shall rely upon:
 - For the University of Coimbra – Professor Dr. João Miguel Santos, FMUC,
 - For TUMS – Professor Dr. Amirreza Rokn, Dean of School of Dentistry.



The terms envisaged in this Addendum will become active once it is signed, running for the same validity defined by the Cooperation Agreement. Any modification or adaptation of this Addendum is subject to written form, requiring prior consent from both parties.
