THE FACULTY OF PHARMACY OF THE TEHRAN UNIVERSITY OF MEDICAL SCIENCES

Considering the wish to develop and enhance the cultural relationship between both Faculties, and recognizing the mutual benefits to be gained through a cooperative programme promoting scholarly activities and international understanding, the Faculty of Pharmacy of the University of Lisbon, located at Av. Professor Gama Pinto, 1649-003, Lisboa, Portugal, represented by its Director, Professor Dr Matilde Fonseca e Castro, and the Faculty of Pharmacy of the Teheran University of Medical Sciences, located at 16 Azar Street, Teheran, Iran, represented by its Dean, Professor Dr Mohammad Sharifzadeh, Enter into this Memorandum of Understanding (MoU) according to the norms, which follow.

1st Article

The purpose of this MoU is to develop academic, scientific and cultural relations between the Faculty of Pharmacy of the University of Lisbon and the Faculty of Pharmacy of the Teheran University of Medical Sciences in training and research. This MoU will enable the parties to carry out training, studies, research and activities of common interest in a more effective and efficient use of the resources of each university.

2nd Article

Both Institutions agree to investigate the possibility of developing the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity, in the future:

1. Exchange of undergraduate and postgraduate students, in a number agreed annually;
2. Exchange of faculty;
3. Conducting collaborative research projects;
4. Conducting lectures and organizing symposia;
5. Exchange of academic information and materials that are consistent with institutional policies;
6. Promoting collaboration in fields of mutual interest;
7. Promoting other academic cooperation as mutually agreed.

3rd Article

The development and implementation of future, specific activities based on this MoU will be negotiated and agreed between both parties, in accordance with the laws and regulations of the respective countries.

4th Article

It is understood that the implementation of any of the types of cooperation stated shall depend upon the availability of resources and financial support. Both parties agree to seek external financial support for applicable research and related projects, which will be developed under the conditions of this MoU, by local, regional, national and international Institutions.

5th Article

The students, teachers and researchers taking part in the exchange programme should contract a personal insurance, covering any health injury or accident occurring during the exchange, and should make proof of it to the host institution.


6th Article

The joint research activities that may result in any potential for intellectual property should be predicted in a separate specific agreement. Both Institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise, following the rules established both at the Regulations for Intellectual Property from the Faculty of Pharmacy of the University of Lisbon and from the Faculty of Pharmacy of the Teheran University of Medical Sciences.

7th Article

This MoU will become effective as soon as signatures are affixed by the parties' authorized representatives. Cancellation of this MoU can be requested by either party, 30 days in advance of the start of the Fall semester.
