

**COOPERATION AGREEMENT BETWEEN  
TEHRAN UNIVERSITY OF MEDICAL SCIENCES, IRAN, AND  
PIROGOV RUSSIAN NATIONAL RESEARCH MEDICAL UNIVERSITY OF THE  
MINISTRY OF HEALTHCARE OF THE RUSSIAN FEDERATION, RUSSIA**

TEHRAN UNIVERSITY OF MEDICAL SCIENCES, Tehran, Iran, hereinafter referred to as “Party 1”, represented by chancellor Dr. Hossein Ghanaati acting on the base of Charter, and the PIROGOV RUSSIAN NATIONAL RESEARCH MEDICAL UNIVERSITY, Moscow, Russia, hereinafter referred to as “Party 2”, represented by rector Sergey A. Lukyanov, acting on the base of Charter, together called “Parties”, intending to establish academic, scientific and technical cooperation programs, decide to enter the following COOPERATION AGREEMENT,

**CONSIDERING:**

- 1) The common interest of maintaining, deepening and developing joint academic, scientific and technical activities.
- 2) The mutual convenience of promoting exchange actions of staff, technicians and students that contribute to the scientific progress and the strengthening of its specialized human resources.
- 3) The intentions that the joint research programs and the projects result in an effective complementation for the progress and development of both Institutions.

**AGREE:**

1. To mutually provide scientific and cultural consultancy.
2. To support the academic mobility by realizing the exchange programs of students, researchers and academic staff, as well as other programs in accordance with law and regulative documents of both of the Parties.
3. To propose and develop joint research projects, in such a way to achieve an effective improvement of human and material resources as well as of the information available.
4. To develop cooperation forms and actions on other areas of mutual interest, such as, the promotion of scientific events, technical cooperation activities, technology transference etc.
5. Agree on the Terms of each joint activity, including goals, mechanisms, implementation time and resources, financial and other conditions through the conclusion of separate agreements.
6. In order to implement a joint project, the Parties will seek, jointly or independently, the necessary financial.

7. In all communications and publications arising from programs developed through this Agreement, both signatory Institutions will be expressly mentioned.
8. The coordination of the cooperation will be accomplished by the following departments of the Parties: Party 1 – Directorate of International Relations of the Office of Vice Chancellor for Global Strategies and International Affairs and Party 2 – Academic mobility group of the International Medical School.
9. This Agreement will be enforced from the date of its signature and its duration will be 05 (five) years. The Agreement may be renewed for a further period of 05 (five) years by mutual consent prior to the expiry of the original.
10. In case of amendment, annexes and termination prior to the expiry of the original shall be communicated in writing with an advance of at least three months.
11. This Agreement is signed in 2 copies in English, each party keeping 01 (one) copy.
