

**ADDITIONAL AGREEMENT FOR STUDENT EXCHANGE BETWEEN
TEHRAN UNIVERSITY OF MEDICAL SCIENCES, IRAN,
AND
PIROGOV RUSSIAN NATIONAL RESEARCH MEDICAL UNIVERSITY OF THE
MINISTRY OF HEALTHCARE OF THE RUSSIAN FEDERATION, RUSSIA**

TEHRAN UNIVERSITY OF MEDICAL SCIENCES, Tehran, Iran, represented by chancellor Dr. Hossein Ghanaati acting on the base of Charter, and the PIROGOV RUSSIAN NATIONAL RESEARCH MEDICAL UNIVERSITY, Moscow, Russia, represented by rector Sergey A. Lukyanov, acting on the base of Charter, agreed to establish the student exchange program.

The following articles define the regulations, by which this program will be included in the Scientific Exchange and Cooperation Agreement between two Universities:

1. The goal of the exchange program is the provision of the additional abilities for the students of both Universities to acquire the international experience by the means of obtaining part of the education in the foreign University, which will contribute the strengthening of the good will and understanding between Iran and Russia.
2. The time of the exchange for each of the students shouldn't be longer than 2 (two) months.
3. No more than 5 (five) students from each institution can take part in the exchange every year. The Parties intend to maintain the approximate balance in the number of the students taking part in the exchange from the each University's side in the period of the agreement's validity.
4. The students that are taking part in the exchange must continue their education as a degree applicant of the University where they have begun the education, not of the University that accepted them for the exchange program.
5. Each University must establish the accepting students for the exchange program procedure. The students that are taking part in the exchange program must carry out the formal requirements of the hosting University, however, each University must, if possible, simplify this procedure in order to ease the exchange program.
6. At the end of the exchange the hosting University must provide the sending University with the information concerning the academic progress of the students that are taking part in the program. The sending University can accept the courses completed by the students according to its internal rules.
7. The students that are taking part in the exchange must be freed from the standard procedure of the admission, registration and educational fees in the hosting University.

8. The hosting University isn't responsible for the personal expenses of the students, such as payment for the arrival and departure, necessary health insurance and medical services, books and other things for studying.
9. The hosting University must assist the students that take part in the program in matters of fulfilment of requirements for the visa and other official demands.


